Karen Sabrsula-Long of the Keep Simonton Beautiful Committee addressed the City Council regarding request of \$3,500 for new Christmas decorations. Mayor Boudreaux briefed the City Council on this history of the Christmas decorations, including the work done by volunteers demonstrating further savings to the City of Simonton. She identified funding sources in the current Fiscal Year 2022-2023 Budget Community Outreach. Following brief discussion by City Council, the City Council took action.

Motion by Councilmember Turner to approve the \$3,500 expenditure authorizing the Keep Simonton Beautiful Committee to purchase new Christmas decorations. Councilmember Matula seconded the motion.
