#### 1. Call to Order at 6:04 p.m.

# 2. Invocation and Pledge

Mayor Boudreaux gave the invocation.

Mayor Boudreaux led the assembly in the Pledge of Allegiance.

#### 3. Public Comments

In accordance with Texas Open Meetings Act and Texas Government Code 551.007, City Council may not discuss or take action on any item NOT listed on the Agenda. Each member of the public wishing to speak must sign-up prior to the meeting and is limited to 3 minutes.

Community Member Kristi Smith spoke to City Council regarding her hopes for reasonable budgeting negotiations and presented Mayor Boudreaux with a trophy in appreciation for her hard work.

# 4. Public Hearing

- a. Mayor Boudreaux opened the Public Hearing at 6:06 p.m.
- b. Public Comments There were no speakers to address the City Council.
- c. Mayor Boudreaux closed the Public Hearing at 6:07 p.m.

#### 5. New Business

# a. Review of 2024-2025 Proposed Budget

Mayor Boudreaux presented a PowerPoint detailing the property tax, sales tax, road maintenance and EDC percentages as they pertain to City revenues. The Mayor clarified that a Super Majority refers to Council's attendance for a vote (4 out of 5 Council Members), whereas a Simple Majority refers to the actual vote (3 out of 5 Council Members).

A review of the proposed \$0.29 ad valorem tax rate versus a \$0.21 rate as it pertains to the proposed budget commenced. Mayor Boudreaux asked if any additional fact-based information was requested. Mayor Boudreaux stated that zoning was a priority, and that zoning and road work

cannot be completed if the ad valorem tax rate is set too low. Mayor Boudreaux stated that any "leftover" (unspent) funds go into the reserves and that if monies are needed to fund the budget, the monies come out of the reserves.

Council Member Kelli Matula stated that the City takes a huge risk of not generating enough revenue at a \$0.21 ad valorem tax rate. Council Member Burns Turner stated that the City <u>can</u> be operated with a \$0.21 ad valorem tax rate. A brief debate between Council Members Kelli Matula and Burns Turner ensued.

b. Adoption of the Budget Ordinance for Fiscal Year 2024-2025 Consider and take action to adopt Budget Ordinance No. 2024-06 for Fiscal Year 2024-2025.

Motion by Council Member/Pro Tem Courtney Cox to adopt her "homemade" budget. At 6:35 p.m., Mayor Boudreaux paused the Council meeting to consult with the City Attorney regarding this new development. At 6:49 p.m., Mayor Boudreaux returned and stated that the Council Meeting would continue.

Council Member/Pro Tem Courtney Cox stated that the budget can be amended if a City Administrator is hired. A lengthy discussion ensued regarding Council Member/Pro Tem Courtney Cox's line-by-line proposed budget cuts. A brief debate proceeded regarding legal fees, \$116,000 of unspent funds from last year and how to generate roadwork funds. Council Member Kelli Matula, upon observing the lack of a budget for Keep Simonton Beautiful (KSB), stated that KSB needs a budget and one that should be separate from other City funds.

Mayor Boudreaux reiterated Council Member/Pro Tem Courtney Cox's Motion to adopt her homemade budget. Council Member Faith Haley seconded the Motion.

# 1. Call to Order at 6:04 p.m.

A quorum was present with the following City Council Members in attendance: Laurie Boudreaux, Courtney Cox, Faith Haley and Burns Turner Kelli Matula and Justin Boudreau were not present

### 2. Invocation and Pledge

Mayor Boudreaux gave the invocation.

Mayor Boudreaux led the assembly in the Pledge of Allegiance.

#### 3. Public Comments

Kristi Smith stated that a \$0.21 ad valorem tax rate will cripple the City.

Susan La Dart stated that Simonton is a general law city and that City Council was not permitted to create their own budget per the Texas Government Code.

Karen Sabrsula Long stated that a \$0.21 ad valorem tax rate will cripple emergency management, Simonton Economic Development Corporations A and B, and prevent roadwork, zoning and necessary technology.

Andrew Perry presented pictures of roads desperately requiring repair and beseeched the Council to get the roads fixed.

Stacey Gootee asked the Council when was the last time they looked at the City's Vision Statement. She stated that the three Council Members who approved the \$0.21 tax rate (Cox, Haley and Turner) have not been through a flood and that she believes what they are trying to "push through" is a crime.

Sarah Jordan stated that she is embarrassed by Council's conduct in previous meetings. She requested the City Council to have fiscal responsibility, to think of the future and to please work together.

- 4. Hearing to Approve the 2024 Ad Valorem No New-Revenue Tax Rate of \$0.21 per \$100
  - a. Opened at 6:19 p.m.
  - b. Public comments

Susan La Dart commented that the Council does not have the Super Majority to approve \$0.21 ad valorem tax rate. She commented that the vote should never have happened as we are a general law city and City Council is not permitted to present their own budget(s).

Andrew Perry stated that he was incredulous at the prospect of a \$0.21 ad valorem tax rate. He does not understand how roadwork or zoning are possible at that rate.

Kristi Smith questioned why we are considering Council Member/Pro Tem Courtney Cox's proposed budget. City Attorney Philip Boedeker stated that we were required to follow the agenda and that it was not appropriate to respond at this time.

Stacey Gootee stated that the City will require two (2) more hearings to pass the new tax rate.



#### ORDINANCE NO. 2024-07

AN ORDINANCE OF THE CITY OF SIMONTON, TEXAS, APPROVING THE FISCAL YEAR 2024-2025 AD VALOREM TAX (DEBT) RATE AND LEVY OF \$0.21 PER ONE HUNDRED DOLLARS (\$100) OF ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY AND APPROVING THE 2024-2025 AD VALOREM TAX (MAINTENANCE AND OPERATION) RATE AND LEVY \$0.21 PER ONE HUNDRED DOLLARS (\$100) OF ASSESSED VALUTION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY; PROVIDING FOR THE ASSESSMENT, LEVY AND COLLECTION OF AD VALOREM TAXES OF THE CITY OF SIMONTON, TEXAS, FOR THE YEAR 2024-2025 AND FOR EACH YEAR THEREAFTER UNTIL OTHERWISE PROVIDED: WHICH SUCH PROVING THE DATE ON TAXES SHALL BE DUE AND PAYABLE; PROVIDING FOR PENALTY AND INTEREST ON ALL TAXES NOT TIMELY PAID; AUTHORIZING EXEMPTIONS; AND PROVIDING A REPLEALER CLAUSE AND AN EFFECTIVE DATE.

WHEREAS, Section 26.05 of the Texas Property Tax Code provided that by October 1 or as soon thereafter as practicable, the governing body of each taxing unit shall adopt a tax rate for the current tax year;

WHEREAS, such Section further provides that where the tax rate consist of two components (one which will impose the amount of taxes needed to pay the unit's debt service and the other which will impose the amount of taxes needed to fund maintenance and operation expenditures of the unit for the next year);

WHEREAS, the proposed tax rate for the current tax year of the City of Simonton, Texas, consists of two such components, a tax rate of \$0.00 for debt service and a tax rate of \$0.21 to fund maintenance and operation expenditures; and

WHEREAS, a budget appropriating revenues generated by the collection of ad valorem for the use and support of the municipal government of the City of Simonton has been approved and adopted by the Simonton City Council as required by Title Four (4) Section 102.009 of the Local Government Code; and

**WHEREAS**, it is necessary and appropriate for the City Council to adopt the 2024-2025 Tax Rate for the City of Simonton, Texas.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SIMONTON, TEXAS, THE FOLLOWING:

- <u>Section 1</u>. The facts and recitations set forth in the preamble of this Ordinance are hereby found to be true and correct and are incorporated herein and made a part hereof for all purposes.
- Section 2. All property subject to as valorem taxation by the City of Simonton, Texas, shall be equally and uniformly assessed for such purposes at One Hundred Percent (100%) of the

fair market value of such property.

Section 3. There is hereby levied for general purposes and use by the City of Simonton, Texas, for the year 2024-2025 and for each year thereafter until otherwise provided, an ad valorem tax at the rate of \$0.21 on each One Hundred Dollars (\$100) of assessed valuation on all property, real, personal, and mixed within the corporate limits upon which an ad valorem tax is authorized by law to be levied by the City of Simonton, Texas. All property subject to ad valorem taxation by the City of Simonton, Texas, shall be equally and uniformly assessed for such purposes at One Hundred Percent (100%) of the fair market value of such property.

Section 4. For the purposes of paying the interest on bonds, warrants, certificates of obligation or other lawfully authorized evidence of indebtedness issued by the City of Simonton, Texas, including the various installments of principal due on serial bonds, warrants, certificates of obligation or other lawfully authorized evidence of indebtedness issued by the City as such installments shall respectively mature and for the purpose of repaying any sums borrowed in anticipation current revenues for use in the payment of 2024-2025 for the purpose of paying interest and making provisions for the sinking fund on such other bond issues, warrants, certificates of obligation, or other lawfully authorized evidence of indebtedness as may be authorized, there is hereby levied for the fiscal year 2024-2025 and for each year thereafter until otherwise provided, to be assessed and collected upon all property described in Section 3 of this Ordinance, an annual ad valorem tax at the rate of \$0.21 on each One Hundred Dollars (\$100) of assessed valuation.

Section 5. All ad valorem taxes levied hereby in the total amount of \$0.21 on each One Hundred Dollars (\$100) of assessed valuation, as reflected by Section 3 and 4 hereof, shall be due and payable on or before January 31, 2025. All ad valorem taxes due the City of Simonton, Texas, and not paid on or before January 31 following the year for which they were levied shall bear penalty and interest as prescribed in the Property Tax Code of the State of Texas.

All taxes shall become a lien upon the property against which assessed and the Tax Assessor/Collector for the City of Simonton, Texas, shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest. The penalty and interest collected from such delinquent taxes shall be appropriated for the general fund of the City of Simonton, Texas. All delinquent ad valorem taxes related to penalties and interest for the tax years prior to 2024, that are collected curing Fiscal Year 2024-2025 shall be allocated to the general fund for maintenance and operation of the City of Simonton, Texas.

# **Section 6.** The following exemptions are hereby authorized:

- 1. (HS) Homestead Local
- 2. (O65) Over 65

4. (DP) Disabled Persons Local (3)
5. (DV) Disabled Vet (5) (HB366) House Bill 366 (2),
6. (AUTO) Lease Vehicles Ex (2)
Section 7. All ordinances and parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
