Consider and take action to approve letter of approval of release of permit to Simonton Community Church, citing National Fire Protection Association rules and regulations stating that any new building over 5000 square feet and any addition bringing the total footprint of a building to an area greater than 12000 square feet will require a sprinkler system of the entire structure.
- b. Consider and take action to approve permitting for all fences in the city in accordance with city ordinance No. 2013-0802.
- c. Consider and take action to approve a permit fee of \$100 for fence permits.
- d. Consider and take action to approve Solar Ordinance for regulating the installation of solar units on residential and commercial properties.

- e. Consider and take action to approve permitting for solar projects in the city.
- f. Consider and take action to approve permitting fees for solar projects. Fee would be \$230 for projects that do not require a reconnect and \$330 for projects that do require a reconnect.
