Commission Member Angela King spoke to Community Member Rachel Reyes (Fred Reyes Greenhouses) regarding preparing a succulent bar as a fundraiser, which would be called Mommy and Me.

Sunset is at 6:30 p.m. so there is plenty of time for the day event to take place. The price to participate will be \$35.

Commission Member Angela King will speak to City Secretary Nanci Mohr about using Square (like we did for Home Tour). Kristi Smith will update the Square message to enable the inclusion of a QR code on all flyers promoting the event.

KSB would have to order colored rocks and decorative plant sticks, but Rachel Reyes would provide everything else. Rachel Reyes will also host a class on how to plant and care for succulents.

Commission Member Kelli Carlson is to send the sponsorship letter to all board members so we can start working on sponsor requests. Commission Member Angela King is to speak with Soto about donating a bounce house for the event.

Discussion regarding possible other ideas for Spring Round-Up including: pictures with one of Commission Member Abbie Ferguson's Highland cows, red truck photo op, face painting, brainstorming regarding other ideas that we haven't done in the past, as well as something new to draw in more kids/families.

d. Consider and take action regarding Welcome Baskets.
