RESOLUTION NO. 2026-02

A RESOLUTION OF THE CITY OF SIMONTON, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN SAID CITY ON MAY 2, 2026 REGARDING THE MAYOR AND TWO COUNCIL POSITIONS.

WHEREAS, under and by virtue of Resolution No. 2026-02, duly resolved by the City Council of the City of Simonton, Texas, and thereafter published in accordance with the law, a General Election was held in the City of Simonton, Texas on May 2, 2026, at which the mayor and two (2) council positions were submitted to the duly qualified, resident electors of the City for their actions thereon; and

WHEREAS, the City Council has investigated all matters pertaining to the general and special election and has determined that notice of said general and special election was actually given as required by law, and said election was duly and legally held on May 2, 2026, in conformity with the election laws of the State of Texas, the City Code of Ordinances and the Voting Rights Act of 1965, and the results of said general and special election has been certified and returned to the City Council by the proper judges and clerks thereof; and

WHEREAS, the Council so finds that the City Secretary has tabulated the results of said general and special election and certified such tabulation for the City Council, and that such tabulation is correct;
